Dr. Buckley called the meeting to order 2:00 pm central.

DASH Updates (Raaj):

• Thanks to Faculty Senate Research Group- for their expert and well delivered feedback to the central DASH leadership team. A plan of correction invoking short term, intermediate, and long-term changes is being rolled out. The continued use of the dedicated website at UT Health Science Center as well as the support and guidance of the task force will be helpful going forward.

Updates on Federal-State Executive Orders and legal situations – (Raaj, Jessica and Cindy):

- Everything we are doing is being coordinated with UT System for a unified and coherent approach.
- Research stopping grants, indirect cost rates, new notices coming out slower than usual. Jessica Snowden and research office meeting with colleges and researchers. Have started a Contingency Planning Group that meets every 2 weeks to assess situations and recommend strategies to more quickly address the rapidly changing environment.
- Dear Colleague letter ensuring that race is not a factor in recruiting, admissions, scholarships, support services, student organizations, diversity statements, accreditation requirements. Cindy and AFSA leaders meeting with deans and relevant people in colleges.
- January 21, 2025, Executive Order on "Ending Illegal Discrimination and Restoring Meritbased Opportunity" - gave us the opportunity to increase efficiencies in hiring processes. Changes in involvement by the Office of Access and Compliance - no longer a required charge to search committees, no longer will be approving candidate pools, no longer involved with search exemptions. HR and Faculty Affairs coordinating to support hiring of staff and faculty. As a collective leadership, we are continuing - like Higher Education institutions nationwide- to evaluate this unstable situation with respect to personnel, programmatic, and financial considerations.
